Executive Summary

The national and Washington area economies have been impacted over the past twelve months by two major run ups in oil prices, a steady although small incremental increase in interest rates, and growing consumer anxiety regarding the housing market, rising inflation, and continuing turmoil in Iraq and the Middle East. Still, the economy has performed well overall and has sustained its expansion into its fourth year.

By mid-year, however, the economy had shown clear signs of slowing down. At the national level, second quarter GDP growth had decelerated to less than one-half its first quarter rate, job growth had slowed, productivity was growing but well below recent rates, energy prices were moving towards new record levels, and the housing market had cooled significantly. Forecasts for the national economy had GDP growth below “trend” or less than 3% for the next six quarters—through the end of 2007.

The Washington area economy has not been immune to these national and global economic forces. While it continues to outperform the national economy and the economies of most other major metropolitan areas, it is also exhibiting the early signs of slowing. At present, the forecast for the Washington area economy has a growth rate exceeding the national rate in 2007 and 2008. However, this projected performance will also be impacted by the growth of its principal sector—the federal government and its local spending. Changes in this source of local economic activity will impact the economy’s future economic performance.

Preliminary data on federal procurement spending in the Washington area for 2005, spending that drives job growth well into 2007, point to a significant slowdown from recent years. Where federal procurement spending in the Washington area increased 16.9% in 2003 and 19.0% in 2004, it only increased an estimated 2.5% in 2005. Even though the 2005 procurement totals are not yet 100% complete, it is unlikely that the final spending total will bring the annual increase anywhere close to the historic average of 8.8%. With slower federal spending growth combining with the national and global forces impacting the Washington area economy, it seems likely that it will grow more slowly over the next several years.

The specific findings of this research are summarized as follows:

- The annual level of job growth in the Washington area has averaged 74,400 over the year’s first half, running ahead of forecast by 9,000 jobs;
- Continuing job growth and low unemployment has resulted in an increasingly tight labor market and is causing labor shortages and growing wage pressures;
- Consumer spending has slowed with expenditures for “big ticket” items and discretionary purchases experiencing softer or deferred demand;

- While the average price of all housing units sold in the Washington area over the first half of 2005 exceed the average for the same period in 2006 by 7%, the number of sales have decreased significantly and listings (supply) have grown raising concerns regarding the housing stock's future price stability;
- Federal spending comprises approximately one-third of the Washington area economy and after growing well above its long-term average rate over the past four years its growth appears to have slowed sharply in 2005; this federal spending slowdown will impact the area's economic growth rate going forward;
- The Washington Coincident Index, which measures the current health of the economy, confirms that the economy has slowed over the second quarter after growing rapidly beginning in 2003;
- The Washington Leading Index, which forecasts the economy's likely performance 6 to 8 months in advance, has decreased five of its last ten months, pointing to slower growth over the remainder of 2006 and continuing into 2007; and,
- The Washington area economy is projected to add approximately 60,000 jobs in 2006 and achieve a growth rate falling in the 3.5-3.8% range.

At present, 2007 is expected to be the year for the transition from the strong growth of the 2002-2005 economic recovery to the business cycle's maturing phase (2008-20XX). How this transition period plays out will be determined largely by externalities (terrorism, oil prices, monetary policy and politics).

For the Washington area, while these externalities also will impact the economy, its performance will be shaped more by the future trend in federal spending, especially procurement spending. The continuing and rapid increase in federal procurement spending in the Washington area has driven the growth of the private sector and measurably increased the area's competitive position in the national economy. In spite of the recent slowing of federal procurement spending and a decelerating growth rate, the Washington area economy is projected to continue outperforming the national economy and remain one of the nation's strongest economies over the remainder of this decade.

The Washington Area Economy At Mid-Year

The Washington metropolitan area economy continues to be among the best performing among major metropolitan areas nationwide with job growth running ahead of forecast (74,000 new jobs, up 2.6%) and unemployment consistently the lowest among major markets (see Table 1). Job growth through mid-year has been on target in Northern Virginia with gains averaging around 40,000 net new jobs. The District of Columbia is generating close to its forecast of 8,000 new jobs and Suburban Maryland is running ahead of forecast with gains exceeding 20,000. The unemployment rate in the District has dropped below 6% and in the suburbs rates are now hovering close to 2.0%.

While payroll jobs (full-time, year-round) have shown above-projected strength in 2006, the less formal job base reflecting contract, self-employed, part-time, and undocumented workers has been growing even faster (2.9%) adding 81,000 new jobs in the year ending in June 2006. This count of resident workers ranged upwards towards 98,000 in late

2005, almost 50 percent higher than the job gain for payroll workers by year's end. These undercounted jobs are typical of a service-based economy and a business environment in which employers are deploying their workers with growing efficiency and flexibility in order to control labor costs. For the economy this growth of jobs, both payroll and non-payroll, is meaningful as these jobs create disposable income and support consumer spending that in turn drives local economic growth.

The non-labor market economic indicators reveal a weaker performance, especially those linked to consumer spending. With consumer confidence lagging, especially confidence in the near term (expectations) due to a change in disposable spending and growing anxiety brought on by higher energy costs, increasing interest rates and concerns about inflation, the weakening housing market, and threats of terrorism and conflicts in the Middle East, consumer spending has weakened—retail sales are lower, tourist spending appears to have slowed, and the volume of housing sales has declined accompanied by a deceleration in price growth and some spot decreases.

The Washington Coincident Index, which measures the current state of the economy, reflects this softening of the local economy. After gaining for 31 consecutive months, the Coincident Index was down in June and July. However, even with this slowing trend the Index is near its all time high and is higher than its peak before the beginning-of-the-decade downturn in 2000.

Federal Contracting in the Washington Area

What explains the Washington area's strong economic performance over the past three years? The answer is federal spending and, more specifically, federal procurement outlays that have increased by an average \$6.23 billion annually over the 2002-2004 period. This substantial federal spending increase has differentiated the Washington area economy from all other metropolitan economies since the 2001 recession.

Federal spending totaled an estimated \$107 billion in 2004 (inclusive of procurement outlays, payroll, retirement and disability, and grants including Medicare) accounting for approximately 35 percent of the Washington area's gross regional product; procurement outlays accounted for 49% of all federal spending in the Washington area. This total value for federal spending in 2005 has not yet been reported (Consolidated Federal Funds Report, U. S. Census) but this total is expected to grow more slowly than in 2004 when it was up 11.4%.

What is now known is that the largest source of federal spending—procurement outlays for locally provided goods and services—increased only slightly in 2005 in contrast to its 19.0% gain in 2004. Preliminary totals (several agencies had not reported all FY 2005 outlays as of August 1) show federal procurement growing by only \$1.3 billion or 2.5%, the smallest gain since 1997. These preliminary spending outlays are reported by sub-state portions of the Washington metropolitan area in Table 2 with detailed tabulations presented in the Appendix.

Federal procurement spending has been the biggest gainer among the major sources of federal spending in the Washington area since 1996 and these gains have been even greater during the three fiscal years immediately following 9/11. For fiscal years 2002, 2003 and 2004, increases in Washington area procurement outlays totaled \$18.7 billion taking total awards to area companies to \$51.1 billion in 2004 (excluding USPS and other off-budget outlays) for the greatest ever one-year gain of 19.0 percent. The spending of these 2004 procurement dollars in 2005 and 2006 is what has driven the economy’s expansion and been responsible for upwards to one-half of the area’s job growth cutting across all sectors.

The increase in federal procurement spending in 2005 was expected to be slightly less than in 2004 but still to have exceeded the historic average (8.8%). However, the preliminary 2005 federal procurement data (August 2006) shows that federal procurement spending increased only \$1.3 billion or 2.5%. While the final total procurement outlays will be somewhat larger (they increased by \$1.1 billion or 14% in subsequent revisions in 2005), they will not alter what must be viewed as a major shift in procurement spending patterns that could have a significant negative impact on the Washington area economy in 2007 and beyond. The slowdown in contract spending during FY 2005 could cost the region thousands of new jobs as contract spending has been found to generate approximately 7,000 new jobs per \$1 billion in additional federal contract spending across all sectors of the area economy.

It should be noted that in addition to the 2005 federal spending data being preliminary, it also excludes local spending by the US Postal Service, the FAA, and other off-budget agencies such as the CIA, NSA, and DIA. Consequently, the total value of federal procurement spending has always exceeded the reported value and this differential has

likely increased as a disproportional amount of the spending increases since FY 2001 has been for homeland security activities cutting across numerous agencies. Still, federal procurement spending, which has driven the region's accelerated growth over the past three years slowed its growth rate significantly in 2005 and this will have a measurable impact on the area's economic performance in coming years.

How big an impact this slowing of federal procurement spending will have on the Washington area economy will be a function of what types of spending have slowed, the multiplier effects this spending would have as it is re-spent in the area economy, and whether this slowdown is a one-year event or a trend that will continue in coming years. The first cut at answering this question shows that the slowdown in procurement awards has not undercut the strength of the area economy (Services and R&D) but rather has affected the delivery of products (see Table 3) that are only wholesaled through local vendors and are not manufactured locally with only a few exceptions. As a result, the economic impact of last year's federal procurement spending reductions will be minor. With the procurement of services and R&D, which constitute 84 percent of all procurement dollars, increasing 6.8% the overall economic impact will be much less than what might at first be expected.

The Near-Term Outlook for the Washington Area Economy

The impact of slower federal spending on the Washington area economy will not be as significant as in the late 1980s due to the economy's increased scale and diversification achieved since 1995. However, if the area's non-federally funded business activities cannot take up the slack due to increasing costs of operation (inflation and interest rate) or growing weakness in national and global markets, then the Washington area economic growth rate can be expected to decelerate faster than is currently projected. These projected GRP growth rates are presented in Table 4.

The employment forecast for the Washington metropolitan area and its sub-state portions is presented in Table 5. With this year's growth of regular, full-time employment averaging 74,000 through seven months, it seems likely that the year-end gain will exceed the 65,500 new jobs forecasted at the beginning of the year. At this time, the estimated job growth in the District and Northern Virginia is on target with Suburban Maryland accounting for the job gains exceeding the forecast. Whether Suburban Maryland's estimated job growth holds through the remainder of the year will be the difference in 2006; in 2005, Suburban Maryland's job estimates were revised downward by almost 50% by the State.

The 2006 job growth rate in the Washington region is projected to equal or surpass the job gain in 2005 that fell below forecast. The job gain in 2005 was in fact much greater than reported in Table 4 as a growing proportion of the area's job growth are self-employed, part-time, contract and even undocumented workers. So far this year, the Household Survey job growth totals are averaging about 80,000. However in 2005, Household Survey reported close to 95,000 new jobs. This discrepancy is pointed out

here to suggest that the job count that is commonly reported and projected does not account for all new jobs but rather only the jobs that are full-time, year-round. As the annual job growth rate (Payroll Employment) is projected to slow further in 2007, 2008 and 2009 these non-payroll jobs take on further importance to the economy's vitality. Job growth in Northern Virginia will account for between 50 and 60 percent of the Washington area total although its job growth will be more susceptible to changes in federal procurement spending and could drop below projection if procurement spending slows at a greater rate than currently assumed.

Summary

At mid-year the Washington area economy was growing at its slowest rate in three years. Still, there were positive signs of the economy's underlying strength as job growth continued to exceed projections for the year and unemployment remained the lowest among major markets in the nation. The principal weakness in the economy's performance was the continuing slowdown in consumer spending with slower retail sales and housing sales reflecting the effects of higher energy costs, increased interest rates, and growing consumer debt burdens. This slowdown in consumer spending may only be temporary with gains in the coming months lifting the economy by the end of the third quarter, but the outlook remains for the year's growth rate to moderate with this trend extending into 2007. Slower national economic growth accompanied by the greater-than-expected deceleration in federal spending growth in FY 2005 is driving this slowdown in the Washington area economy and these forces are expected to slow the economy's performance further in coming quarters.

The national and area economies have been tested over the past year by unexpected changes that in past years resulted in major reductions in economic performance. The economy's fundamental strengths and resultant resilience have enabled it to push through

these threats with only minor reductions in output and slowing of income and job growth. With the economy at the mid-point of the current business cycle, its slowdown is most likely temporary as consumers reposition their personal debt and the imbalances in the global, national, and local economies are smoothed out.
