Dulles Region Defined

The Dulles Regional Chamber of Commerce defines its region as centered on the new control tower at Dulles International Airport and extends roughly 8 miles in all directions. This area includes communities in both Loudoun and Fairfax counties. The communities include Herndon, Reston, Chantilly, Sterling, Ashburn, Arcola, South Riding, Sully, Oakton, and parts of Centreville.

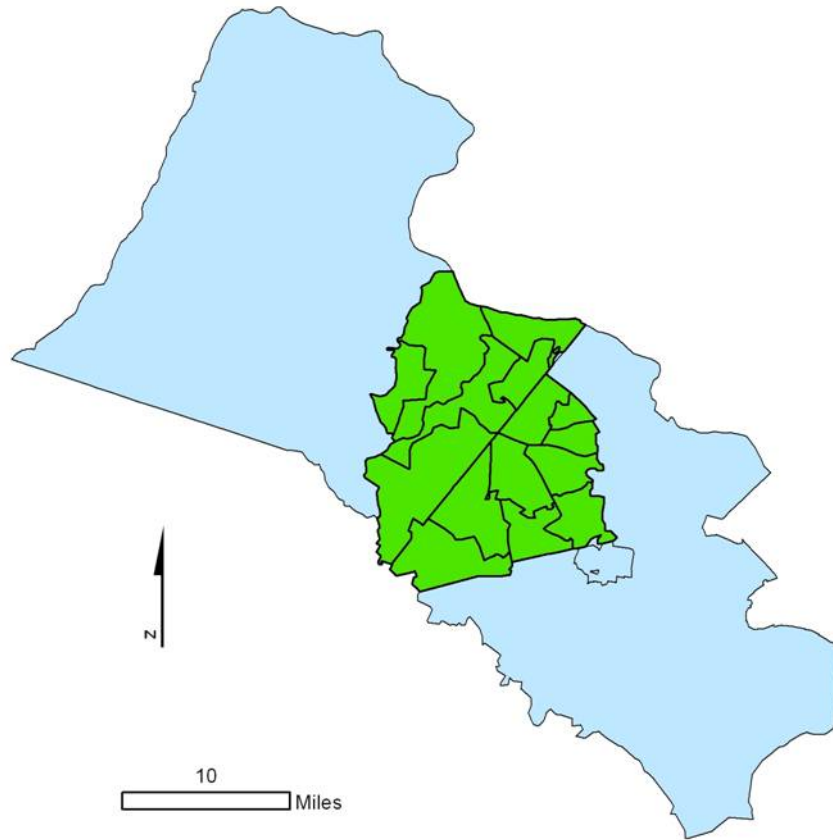
Most of these communities are unincorporated and therefore many official statistics are not reported in a way that allows comparable statistics for the Dulles Region. This data book attempts to fill in the gaps by collating the available data into one source.

There are data available at the zip code level. While the zip codes provide a nice overlay for most of the Dulles Region, some zip codes have only a portion of their area within the Dulles Region. Two of these zip codes (20121 and 22030) have a large portion of their businesses in the Dulles Region, but only a small fraction of their residential area. For this data book, the residential portion of their zip codes is not included and a portion of their economic data was added to the region's total.

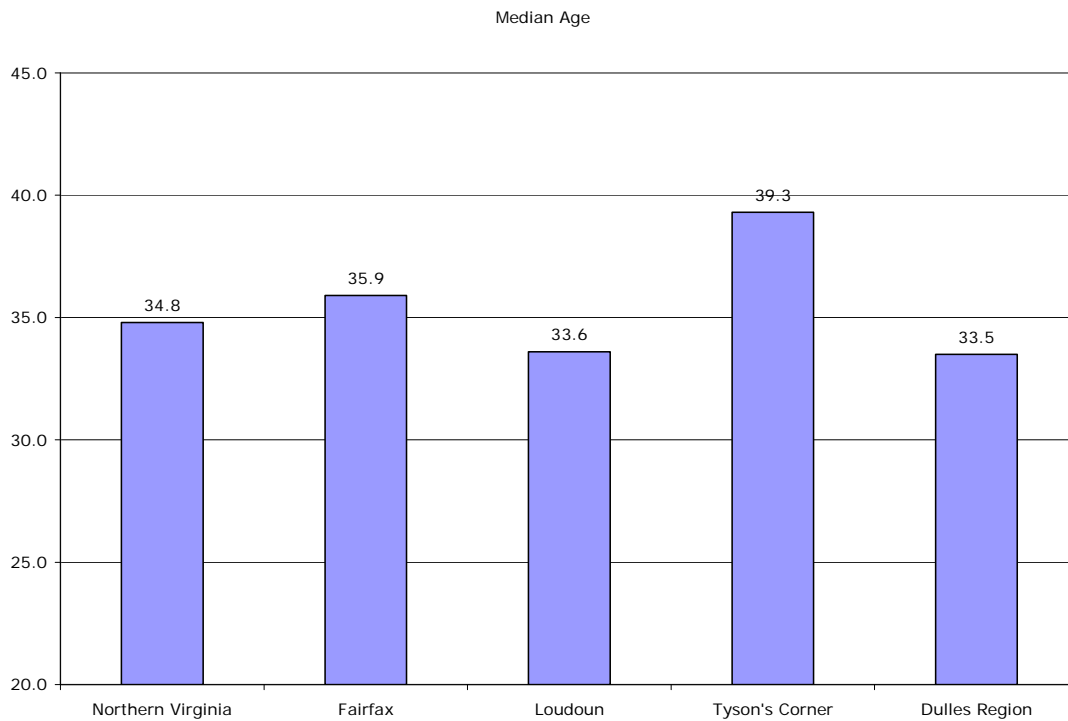

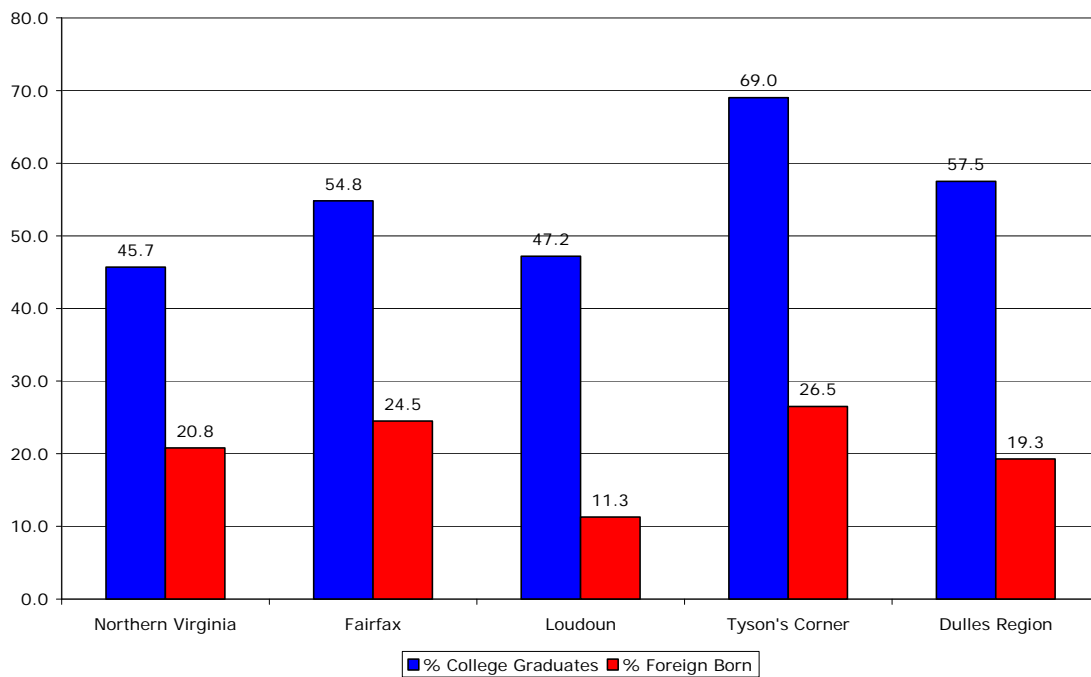

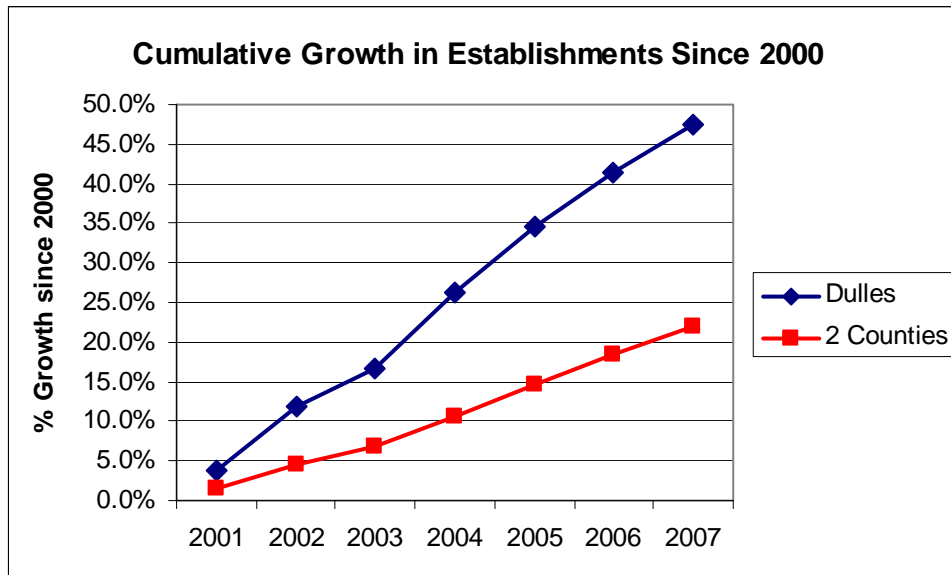

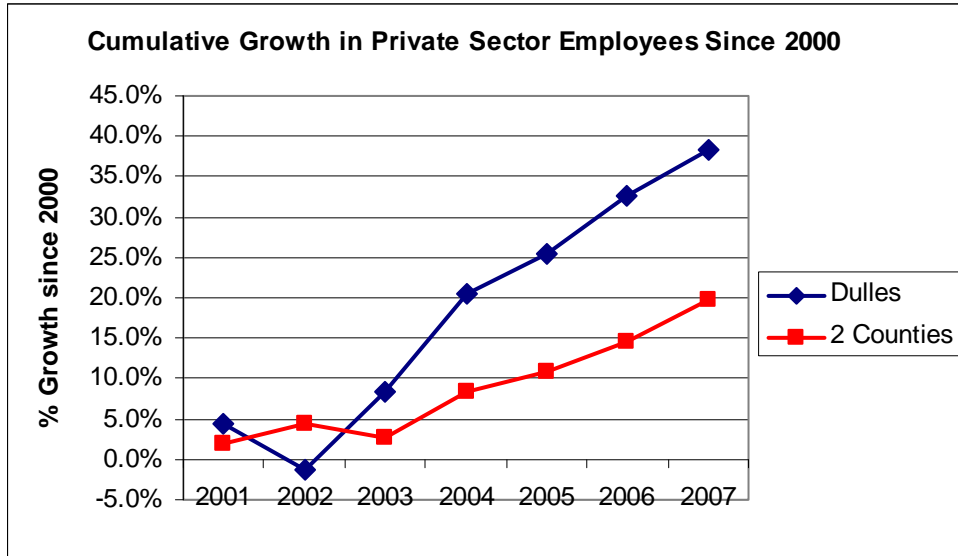

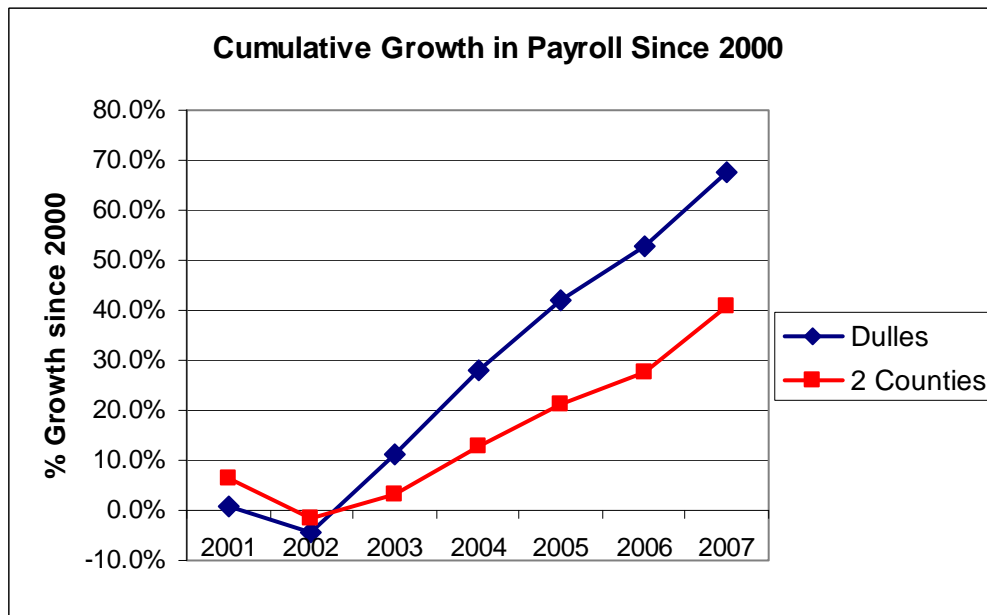

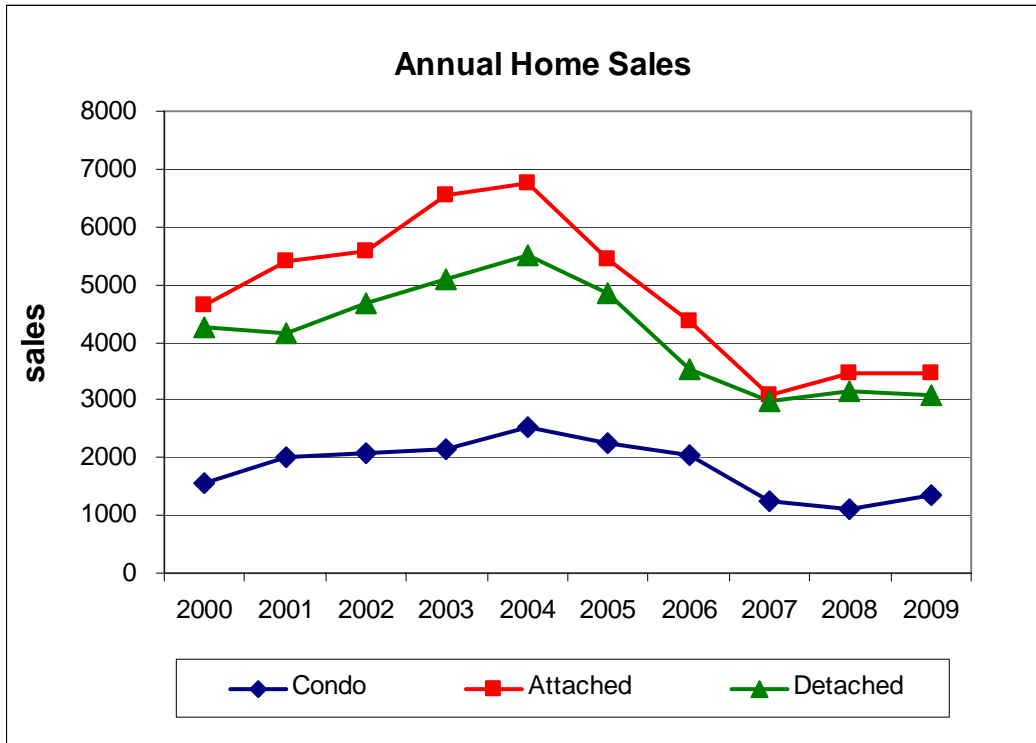

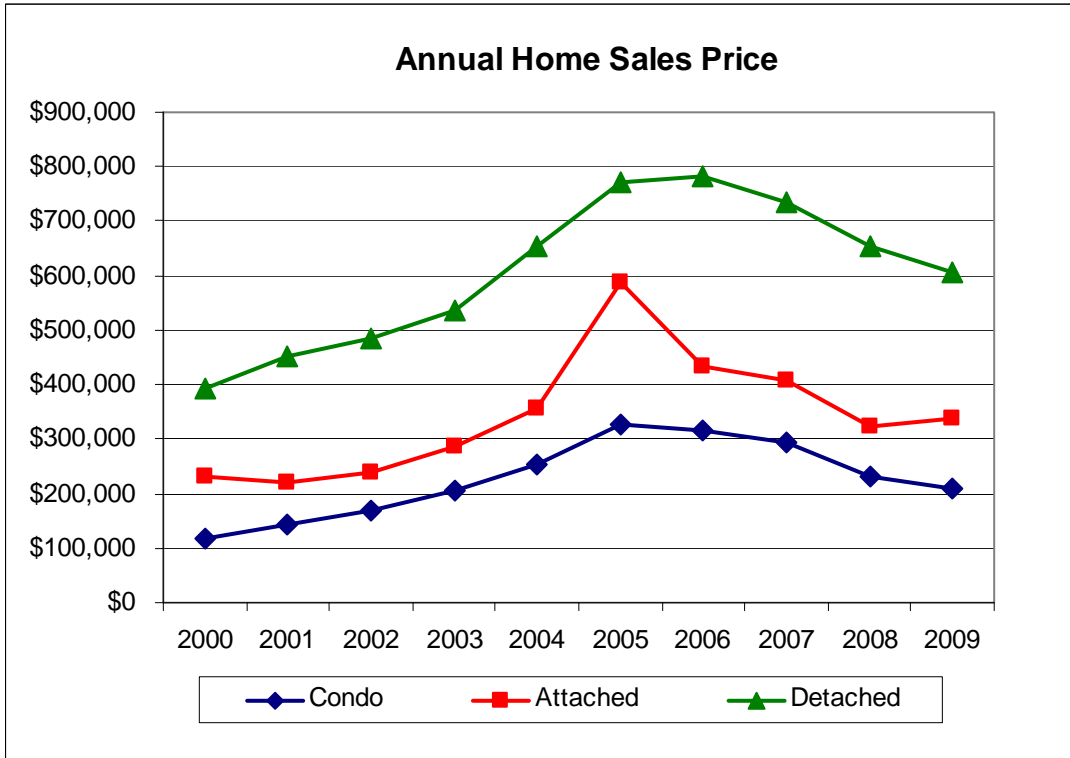
Dulles Region: Existing Home Sales Trends, 2000-2009

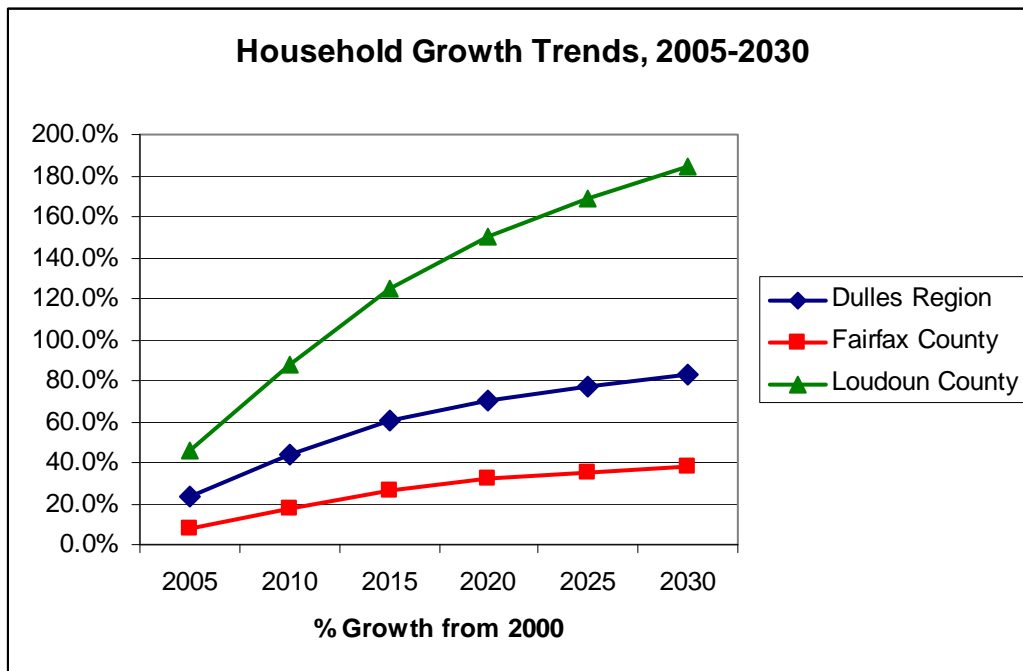

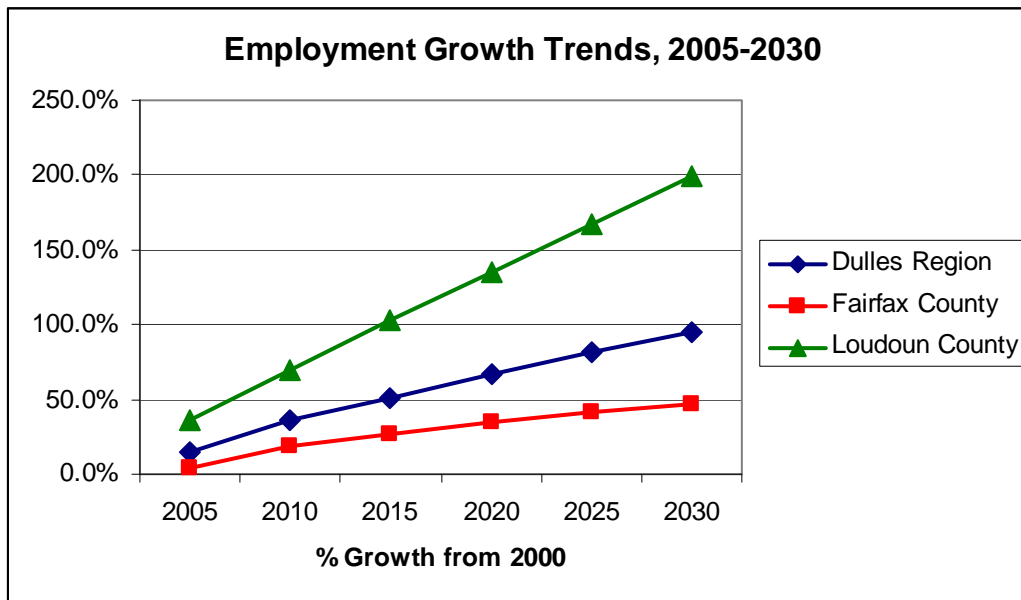

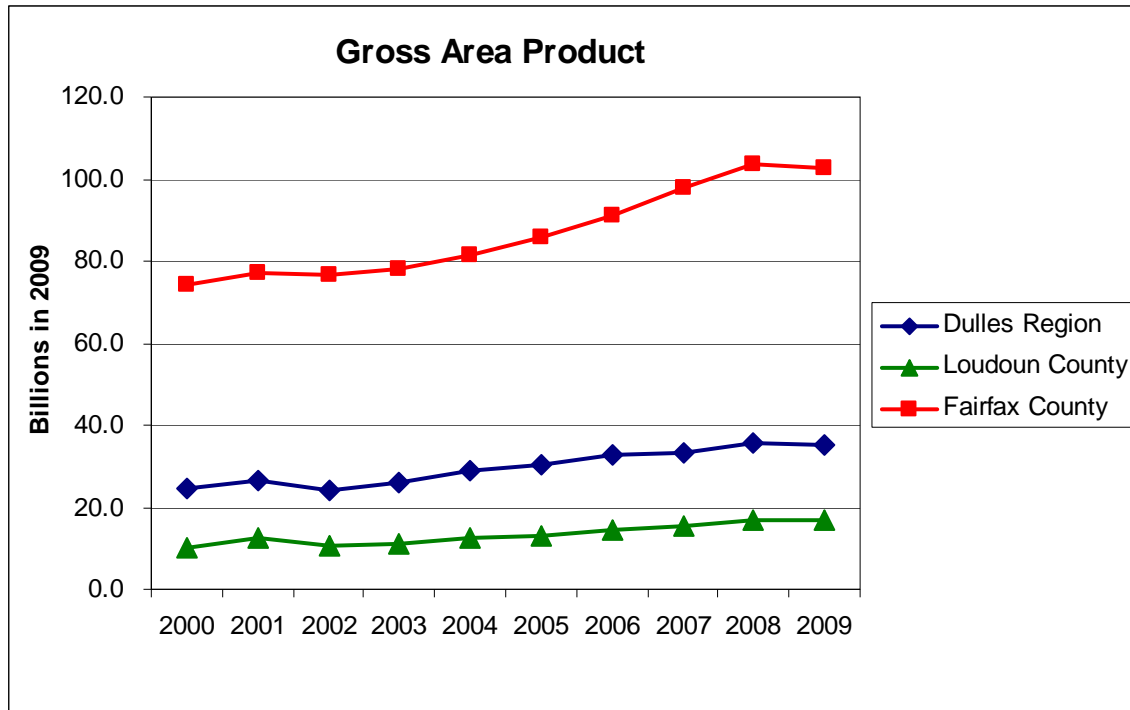
